**Terms & Conditions :**

- a) Quotation should be sent in sealed envelope bearing quotation enquiry No. & should mention - "**Quotation for medicines**" should be clearly written on envelope. Quotations should be addressed to "**The Dean, I.G.G.M.C. & H., Nagpur.**"
- b) Quotation should be send by post or by hand delivery to reach the office before **5:00 Pm on Dt. 31/07/2018**
- c) **Submit the documents which are required to stock and supply the spirit** along with quotation in same envelope.
- d) Quotation enquiry is available on institute website and in medical store.
- e) Quoted rates should be free delivery of goods at I.G.G.M.C. & H., Nagpur, premises only.
- f) Quoted rates should be inclusive of all taxes/GST.
- g) The rates of the drug items must be submitted in the same order of the enclosed drug list on companies/ firm letter head. Or fill in quotation list which is enclosed herewith along with rubber stamp/sealed of firm with signature on each page of list.
- h) Supplied goods should be of good quality as per specification mentioned in IP/ BP / USP standards.
- i) Defective goods, stopped used / samples for physician use will not be accepted and will be returned to the concerned firm. Such act may lead to the supplier getting black listed.
- j) No changes in quoted rates will be considered once the quotation is submitted. For accepted quotations it is mandatory for supplier to supply the goods within stipulated period, otherwise order will be treated as cancelled.


