RULES & REGULATIONS (before filling application forms read rules carefully):
1. A candidate must be citizen of India. Must have passed SSC & HSC from Maharashtra state. ONLY Candidates Domiciled of Maharashtra will be eligible. The candidate shall submit Domicile Certificate along with application form (Residential proof will not be considered as Domicile).

- 2. A candidate Domiciled in Maharashtra, but having constitutional reserved category documents of other state will not be eligible for reserved category claim. However, if such candidate submits Domicile certificate he/she shall be considered for admission as open category student.
- 3. Candidate who have passed HSC examination with Physics, Chemistry & Biology (PCB) shall be eligible.
- 4. Candidate who have passed HSC examination (Medical Lab Technician-1, 2 & 3) are also eligible for concerned speciality technical course ONLY.
- 5. Eligible Candidate must have born on or before 31-12-2007.
- 6. The student should apply in person (anybody on behalf of student can submit application). Kindly note, the application format is attached with this advertisement. The same format without any editing/additions should be used for submission. Student should download the advertisement print application form back to back. The students shall submit applications to Student section Indira Gandhi Govt. Medical college, Nagpur.
- 7. Application along with all self-attested documents will be mandatory. The student should verify all information in the application before final submission. Corrections / Over writing / scratching in the application form will NOT be accepted. Application will NOT be accepted via email/Fax/Post/Courier. Forms will be accepted after verification by scrutiny committee.

CONDUCT AND DISCIPLINE: Failure of the candidate in making full and correct statements in the application form and/or suppression of any information would lead to disqualification of the candidate, even at later date. Such a candidate will be debarred from the entire selection process. It is responsibility of every candidate to submit proper documents. Any attempt to submit documents which are not genuine will lead to cancellation of the admission of the candidate, forfeiture of the fees, deposits and expulsion of the candidate from the college by the Dean or by authorized official.

If any candidate / authorized representative or person accompanying is found obstructing the admission process, or trying to influence in unlawful manner/ creating nuisance, the candidate shall be liable for disqualification from the process of selection and appropriate legal action will be taken.
